# POSITION TITLE: REGISTERED NURSE

HOURS: Part Time (20 hours per week on average)

The **Council on Aging-Southern California** is a private, nonprofit corporation, serving older adults and individuals with disabilities in Orange County since 1973. The Council mission is to promote the independence, health, and dignity of older adults through compassion, education, and advocacy.

Concierge Care Navigators is a fee-for-service Geriatric Care Management program designed to eliminate fragmentation in care delivery. The Registered Nurse will advocate for older and disabled adults, providing short-term consultation and ongoing care management. Our services include evidence-based practices consisting of comprehensive assessments, coordination of care with physicians and health care providers, individualized online care plans with medical and non-medical goals, strategies for goal attainment, and linkages to supportive information and resources.

**POSITION OBJECTIVE:** To serve as trusted resource that creates a care plan linking client, family member, healthcare providers, physicians, community resources. Provide advice, insight and support while monitoring client cases in compliance with clinical standards.

### JOB FUNCTIONS (including but not limited to):

- Conduct onsite client assessments in home, hospital or other facility and discuss family's concerns
- Conduct functional living assessment (ADL's and IDAL's)
- Perform home safety check and make recommendations as needed
- Gather appropriate information related to client based on comprehensive data collection, including review of medical records as appropriate
- Obtain client documents and forms utilizing approved procedures that include POA, Advance Health Care Directive, Physician and insurance information.
- Develop a comprehensive care plan for client to receive appropriate level of care with department Certified Nurse Care Manager RN in a timely manner and prior to implementation of designated services
- Identify risk factors, barriers to goals, and strengths that will assist the client in achieving goals
- Provide/coordinate private and community resources to support clients/families regarding options for support resources
- Accompany client to physician appointments and other professional appointments as requested by client/family
- Provide Medication Management
- Assist in discharge planning from hospitals and skilled nursing facilities
- Foster improved family engagement through active listening and assistance in conflict resolution
- Provide prompt access to COASC's no-cost programs and services

Collaborate, report to and consult with Director of the CCN Program and the Certified Nurse Care Manager RN regarding client care and establishment of medical and non-medical goals. Copy Nurse Care Manager and Director on any communications when email correspondence is submitted to the client and/or family member

• Other duties as assigned by the Director of CCN Program and the Certified Nurse Care Manager RN
